						I was an organizer for the move from Oak Leaf Mobile Home Park to temporary housing and back to Oak Leaf after St. Vincent de Paul of Lane County finished renovations. As a result, I have noticed many mobile home parks that are at least as neglected as Oak Leaf once was. I believe the city needs to create a livability code for these parks and then the city should create and fund a department that sites these owners for neglect and doesn't let them sell until the park is brought up to code. I also think the state and city and region should have a fund that loans money at reasonable rates to park owners as they contract for improvements to bring them up to code. This code of livability should apply to other low income housing as well. Oak leaf wasn't hooked up to the city sewer system and was riddled with rats who fled the scene as soon as bulldozers pulled in. (Of course an exterminator/vector control team should have been called in before the bulldozers. One can guess that rats, raccoons and mice would abound where livability has
